LEGAL NOTICE OF PUBLIC HEARING ON THE BUDGET

A PUBLIC HEARING on the proposed 2025 Fire District Budget for the West Crescent Fire District will be held at 7:00 p.m. on Thursday October 17th, 2024 at the West Crescent Fire Station, 1440 Crescent Road, Clifton Park, NY 12065, in the Town of Halfmoon, State of New York.
